The meeting was turned over to our guests Sheriff David Vincent and Major Bobby Lambert re our safety concerns for Halloween night.

- This has grown and is becoming a safety issue.
- Suggestion was to block the roads but this is really impractical and we do not want this turning into an "Event" where the POA would be responsible. If roads are blocked, we would then have a parking issue.
- Sheriff Vincent told us that community engagement is a priority for their department and they agreed we need a safe evening for the trick or treaters.
- Major Lambert suggested that we could have a one-way system and a speed limit. A left turn only for 3
  hours from 6pm until 9pm. We have three ways in; the Deputies would use cones and barriers. Also
  provide extra personnel in addition to our two paid officers.
- ATVs will not be allowed in especially if towing trailers as this is illegal on county roads.
- Sheriff Vincent suggested extra lighting that they would bring in.
- Major Lambert said they would also use drones to check on the crowds within the neighborhood.
- Major lambert told us he will develop a plan and get back to us before the end of the month. They will also post these new rules on the Sheriff's Facebook page.

- Andy talked to an attorney about the situation on 215 W. Chase. It was decided to give Mr. Soto one last chance and one last letter was sent to him. So far, he seems to be in compliance with keeping his vehicles off the front lawn.
- 30 Ipswich has trailers in their front yard. They are in the process of moving out.
